Applications received after the deadline will not be processed until after June 30, 2010. Scholarships are subject to fund availability.

## IV. Disclosure Statement

I understand that the financial aid application is not valid until I have signed this sheet, and my financial aid package will not be complete until I have completed my FAFSA enrolled in classes at TTU. Intentional false statements or misrepresentation of any of the financial aid materials are punishable according to Federal law. If I determine corrections need to be made to any of the information I have previously submitted to apply for financial aid, I will contact the Tennessee Temple University Financial Aid Office for assistance.

I understand TTU reserves the right to modify my financial aid awards at any time due to changes in my financial aid eligibility or in the availability of funding. I am required to notify the Financial Aid Office of any changes in my financial status. (For example, if I receive any private scholarship or private loan not listed on my award letter.)

I understand that all scholarships are based on full-time residential enrollment (12 hrs). If I am enrolled in less than 12 hours of residential classes, I will not qualify for scholarships and federal aid may be reduced if enrolled less than full time. I also understand that if I live off-campus, my scholarship may be reduced by 50%. **Grades will be evaluated at the end of each semester and scholarships will be removed if the cumulative GPA is below the scholarship standard.** Students must reapply for scholarships after the cumulative GPA is raised. Institutional scholarships may not be stacked without approval from the financial aid committee.

I understand that NO cash refund will be given to me as a result of receiving any institutional scholarship in combination with another institutional scholarship, TTU work scholarship, Federal grant, or State grant. If an overage exists, institutional scholarships will be lowered in the amount of the overage. I understand all scholarships are listed in the amount of what I may receive. I may not receive the entire amount due to various reasons. Grants and scholarships will be credited to my Business Office account within two weeks after my financial aid file is complete and enrollment has been verified. Loan amounts will be posted when loan funds are received from the lender.

I understand that Federal Work Study (FWS) and TTU work scholarship amounts are estimates only. FWS and TTU work scholarship students will receive payment via credits to their Business Office accounts according to the hours worked.
